In the summer of 1781, the Marquis de Lafayette faced off against a powerful British army led by Lt. Gen. Charles, Lord Cornwallis in Virginia. These operations eventually led to the Siege of Yorktown, where Cornwallis eventually surrendered to American forces under General George Washington.

On Saturday, April 28, join U.S. Army historian **John Maass** on a tour of sites associated with Lafayette and his campaign in the Williamsburg and Yorktown areas. Sites include Bottom's Bridge, New Kent Courthouse and Tavern, Tyree Plantation, Hickory Church, Chickahominy Church, Spencer's Ordinary, Diascund Bridge, Romancoke Plantation encampment, St John's Church, Claiborne's Ferry and Green Spring Battlefield.
